Trial closes, and no pre-entries will be accepted **POSTMARKED** after Monday, June 4, 2021  
If the trial should fill prior to that date, entries will be accepted **FIRST COME** per postmark.

If this trial does not reach 350 runs we will accept day of show entries.

Entries are limited to 350 per day.

**Confirmations will be emailed to all entered  
and a date by which any corrections must be received by the trial secretary.**

ASCofSDC will offer Ribbons for first through fourth place in each class, and for each jump height.  
Green ribbons will be offered to any dog that attains a qualifying score. Rosettes for new titles!  
Rosettes for High In Trial (Elite, Open, Novice, Veteran and Junior Handler – CH Program only)

HIT will be calculated based on the level of the dog in the regular class. 7 pts. for each Elite 10 pt. Q, 6 pts for each Open 10 pt. Q, 5 pts. for each Novice 10 pt. Q, half the point value for faulted Qs. Tie breaker will be fastest combined YPS (average). (Please note HIT will be calculated for Sat/Sun runs only)

**Event Rules:** This event will be held in accordance with the rules and regulations of the Australian Shepherd Club of America.

Exhibitors, through submission of entry, acknowledge that they are knowledgeable of the rules and regulations of ASCA, and agree to abide by all rules in effect at the time of this trial.

No entry will be accepted by any dog or handler disqualified from all ASCA programs or anyone not in good standing with ASCA.

*Equipment list: Slat-less rubber covered contact obstacles (A-Frame, Teeter, Dog walk), open tunnels, non winged jumps, weave poles (24").*

**Club Rules:** All dogs must be on leash when not competing in the ring. Please clean up after yourself and your dog. Please take responsibility for your dogs and children. Any exhibitor whose dogs or children create unnecessary disturbances or engage in unsafe or disruptive behavior may be asked by the Trial Committee to leave the trial site. No entry will be refunded if the trial cannot open or be completed by reason of riot, civil disobedience, fire and act of God, public emergency, and act of a public enemy, or any other cause beyond the control of the organizing committee. There will be no refunds for entries withdrawn after the closing date, or in the event a dog and/or handler are dismissed from competition, regardless of the reason for such dismissal.

Checks not honored by the bank do not constitute a valid entry. There will be a \$25.00 service charge for returned checks.

**All dogs can receive ASCA agility titles**

ASCA requires a 'QTracking' number for all non-ASCA registered dogs if you wish to have your scores recorded for titles. *If you are not concerned about ASCA titles, you do not need register your dog to enter and compete in the trial.* Forms for ASCA QTracking numbers & service membership are included in this premium, available at the ASCA website, <http://asca.org/Forms/trackapp.pdf>, and will be available at the trial. ## ASCA® Service Membership and QTracking Number Application

**For non-ASCA registered dogs** – In order to have ASCA qualifying legs tracked and to receive ASCA titling certificates, each non-ASCA registered dog will be required to have an ASCA QTracking Number. This is a one-time fee of \$10/dog. At the time of applying for the QTracking number, the individual owner must also be an ASCA member (minimum membership type of 'Service' is required). ASCA membership does not need to be maintained in subsequent years. **It will be the responsibility of the owner to identify to ASCA the show(s) and leg(s) earned when applying for a QTracking Number for those ASCA qualifying legs earned before submission of application.**

**Agreement**

The person who signs this agreement represents that he/she is authorized to enter into this agreement on behalf of both exhibitor and the owner of entered dog. In consideration of acceptance of this entry the signor also agrees:

- As used here "ASCA" means the Australian Shepherd Club of America, its affiliate clubs, and each of their members, officers, directors, employees, show chairs, show committees and agents.
- Exhibitor/ owner agree to abide by the rules and regulations of ASCA, and any other rules, and regulations appearing in the premium for this event.
- Exhibitor/owner certifies the entered dog is not a hazard to persons, dogs, or property and that the entered dog's rabies vaccination is current in accordance with the requirements of the state in which the dog resides.
- Exhibitor/owner acknowledges all hazards presented by the event, and the event premises, including but not limited to, the conditions of the grounds, lighting, security measures, or lack thereof, electrical appliances, fittings, show rings, parking areas, the presence of unfamiliar animals, and people, and assumes the risk of harm arising from any of these.
- Exhibitor/owner releases ASCA including all officers, directors, employees, and members, ASC of San Diego County and Reggie Field, including all owners, employees, officers, directors, agents members, organizing committees, and will defend and hold them harmless from all present and future loss, injury, damage, claims, demands, and liabilities involving the entered dog, the event, or event premises. Without limiting the generality of the foregoing hold harmless provisions, exhibitor/owner hereby specifically assumes responsibility for and agrees to indemnify, and save aforementioned parties harmless from any and all loss and expenses including legal fees by reason of the liability imposed by law upon any of the aforementioned parties for damages because of bodily injuries, including death, at any time in consequence of my/our participation in this event, howsoever such injury or death may be caused, and whether or not the same may have been caused, or may have alleged to have been caused by negligence of the aforementioned parties, or any of their employees, agents or any other persons.
